

Planète Française WAIVER



In consideration of my child/ren's participation in P.W. Leopard Ltd.'s Planète Française sports and camp activities ("Activities"), I, the undersigned, being the parent or legal guardian of a minor child, hereby declare and agree as follows:

Risks: I agree that the Activities involve risks and dangers that may cause serious personal or fatal injury and loss or damage to personal property. These risks are inherent in the Activities and cannot be eliminated without altering their character and value.

Assumption of Risks: By participating in the Activities, my child/ren and I assume all risks, inherent or not. I have discussed the activities and risks with my child who wishes to participate and to whose participation I consent.

Release and Indemnity: I, parent or guardian of a minor child, hereby waive, release and agree not to pursue or sue P.W. Leopard Ltd.'s Planète Française and their respective shareholders, directors, officers, employees, contractors, sponsors, partners, agents, successors, heirs, executors and personal representatives (the "Released Parties") with respect to any and all liability for injury, death, property loss or damage, or any other loss, cost or expense that I or my child or any member of our families may suffer or incur, as a result of my child's participation in or viewing of the Activities. I further agree to indemnify, defend and save harmless, and pay or reimburse (including costs, damages and reasonable lawyers' fees), the Released Parties for any claim, by whomever it might be brought, including me, the child, and members of our families, arising from my child's participation in or viewing the Activities. The claims hereby released and indemnified against include those due to any cause whatsoever, whether caused by the negligence of a Released Party, breach of contract, breach of warranty, strict liability, breach of a statutory (including applicable occupiers' liability legislation) or other duty, or otherwise.

Other: 1. I consent to having photos and videos taken of my child while he/she participates in the Activities. I agree that P.W. Leopard Ltd.'s Planète Française may use such photographs or videos, without payment by P.W. Leopard's Planète Française, for promotional or instructional purposes or for publication by the news media. I agree that such photos and videos shall remain the intellectual property of P.F. Leopard's Planète Française, and I waive any moral rights thereto.

2. I consent to first aid and emergency medical care being administered or obtained by P.W. Leopard's Planète Française staff. I also consent to P.W. Leopard Ltd.'s Planète Française Day Camps staff or other P.W. Leopard Ltd.'s Planète Française employees transporting my child/ren to a local doctor or hospital for medical treatment if necessary. I agree that I am responsible for all costs of any medical treatment.

3. I agree that any litigation between me, my child or members of our families, on the one hand, and any Released Party, on the other, will be within the exclusive jurisdiction of courts of the Province of Ontario and that the laws of Ontario apply to this Waiver.

4. Cancellations any time before 3 weeks of the July 1st, receive 50% refund minus \$20 Admin fee/full credit towards another week within the current Summer schedule (if spaces are available). If spaces are not available, there will be a 50% refund minus a \$20 Admin fee. No refunds will be offered 2 weeks prior to July 1st. The option will be credit if space is available in another camp within current Summer schedule. Camp fees are for the entire camp session; not a day-by-day basis. Planète Française will therefore not refund fees for days missed for any reason. If a camp session switch can be accommodated, it must be requested at least two weeks prior to the start of the session. Any switch requested within two weeks prior to the start of the session will be subject to a fee.

5. The Health Form and the Health Safety Forms found on the website will be complete prior to the final payment schedule of June 1st.
